Procedure:

The matter was considered by the Building Practitioners Board (the Board) under the provisions of Part 4 of the Building Act 2004 (the Act), the Licensed Building Practitioners Rules 2007 (the Rules) and the Board's Procedures for the Management of Appeals (the Appeal Procedures).

Decision:

The Board has decided, under section 335 of the Act, to confirm the decision appealed against and **not** grant the Site AOP 3 license.

Summary of the Board’s Appeal Decision

[1] The Appellant is **not** granted a Site AOP 3 license.

The Board

[2] The Board is a statutory body established under the Building Act.¹ Its functions include hearing appeals against certain decisions of the Registrar in accordance with subpart 2 of Part 4 of the Act.

Procedure on Appeal

[3] Under section 335 of the Act, an appeal proceeds by way of rehearing. On hearing an appeal, the Board may confirm, reverse, or modify the decision or action appealed against. The Board may also make any other decision or take any other action that the decision maker (the Registrar) could have made. The Board cannot review any part of a decision or action not appealed against.

The Registrar’s Decision

[4] To become licensed, an applicant person must satisfy the Registrar that they meet the applicable minimum standard for the class or classes of licence applied for. ²The minimum standard is prescribed by rule 4 of the Rules. It states:

**4 MINIMUM STANDARD OF COMPETENCE FOR EACH CLASS OF
LICENCE**

- (1) *The minimum standard of competence for a class of licence is meeting all of the competencies set out for that class of licence in Schedule 1.*
- (2) *In determining whether a person meets a competency, regard must be had to the extent to which the person meets the performance indicators set out for that competency in Schedule 1.*

[5] Under rule 12 of the Rules, the Registrar must make a decision on the application. The Registrar's decision to grant or decline a licence must be informed by an assessor's recommendation.³

[6] On 1 August 2022, the Registrar informed the Appellant that his application had been declined. The Appellant was informed of his right to appeal the decision.

The Appeal

[7] On 12 August 2022, the Appellant filed an appeal with the Board against the Registrar's decision.

[8] The Board's Appeals Procedures stipulate that the Registrar is to provide a report that includes all evidence used to reach the decision, including the assessors' recommendation (the Report). The Report noted the Appellant had failed to demonstrate the following competencies for the class of license applied for:

- (a) Competency 3
- (b) Competency 4
- (c) Competency 5

[9] Under section 335(4) of the Act, the Board must not review any part of a decision or action not appealed against. On that basis, and on the basis of the Report, the matters under appeal were those noted above.

[10] The burden of proof lies with the Appellant. It is for the Appellant to provide sufficient evidence to establish, on the balance of probabilities, that he meets sufficient of the performance indicators for those competencies that are being appealed to be granted a licence. If the Registrar appears at an appeal hearing,⁴ the matter proceeds using an adversarial process.

[11] The Registrar did not seek leave to appear.

The Hearing

[12] Prior to the hearing, the Appellant provided further evidence to support the appeal. In particular the Board was provided with a statement as to his work experience, copies of a [OMMITED] award and a [OMMITED] Manager award from projects in China, a reference letter from the Appellant's current employer and the name of a further referee.

- [13] At the hearing, the Appellant summarised his building background and current work situation. This included detail on his qualifications and building experience in relation to the licence class sought. He also provided detail on how he considered he met the required competencies.
- [14] The Board questioned the Respondent as regards the performance indicators in Schedule 1 of the Rules for those competencies that were appealed.
- [15] The Board drew on a white board a mock scenario and used this to question the Appellant on site set up and management, construction management and monitoring, and potential issues (including directing technical supervision personnel) through to practical completion and the appropriate documentation to confirm compliance with the building consent.
- [16] In addition, the Board tested the Appellant's knowledge of matters such as records of work, restricted building work and the Licensed Building Practitioner's scheme.
- [17] The Appellant was given the opportunity to contact his further referee who was available by telephone, but he decided not to do this.

The Purposes of the Licensing Regime

- [18] The Building (Definition of Restricted Building Work) Order 2011 (New Zealand) stipulates that design work and building work on the primary structure and external moisture-management system of a house, or a small-to-medium apartment building is restricted building work. Restricted building work on applies to work that is carried out or supervised under a building consent⁵.
- [19] Under section 84 of the Act:
- All restricted building work must be carried out or supervised by a licensed building practitioner [who is licensed] to carry out or supervise the work.*
- [20] Given the above provisions, a person who wishes to carry out or supervise restricted building work, other than as an owner builder, must be licensed.
- [21] The introduction of the licensed building practitioner regime was aimed at improving the skills and knowledge of those involved in residential construction. The following was stated as the intention to the enabling legislation⁶:

The Government's goal is a more efficient and productive sector that stands behind the quality of its work; a sector with the necessary skills and capability to build it right first time and that takes prides in its work; a sector that delivers good-quality, affordable homes and buildings and contributes to a prosperous economy; a well-informed sector that shares information and quickly identifies and corrects problems; and a sector where everyone

involved in building work knows what they are accountable for and what they rely on others for.

[22] And, as was noted by the responsible Minister during the first reading of the legislative provisions that established it:⁷

A robust licensing scheme with a critical mass of licensed builders means consumers can have confidence that their homes will be built right first time.

[23] Within that context, it is important that the competence of those who seek to be licensed is thoroughly assessed so as to ensure that the legislative purposes of licensing are advanced, consumers are protected, and buildings are designed and constructed in a manner that makes them safe and healthy.

Board's Conclusion and Reasoning

[24] On the basis of the evidence received and having taken into consideration the purposes of the licensing regime, the Board has decided that it will confirm the decision appealed against.

[25] In making its decision, the Board noted the appellant had a basic level of knowledge across competencies 3, 4 and 5 but his knowledge lacked depth. For example, whilst the Appellant could identify that a site safety plan was needed, he could not explain what should be included in that plan. In answering the Board's questions, the Appellant appeared to lack the real-life experience of and exposure to issues on site.

[26] The Board was concerned that the Appellant did not have an adequate understanding of important concepts such as a record of work and restricted building work.

[27] The Board recommends that the Appellant focusses on obtaining more on-site experience and therefore gaining a greater depth of knowledge in the areas of competencies 3, 4 and 5 of a site licence before reapplying.

Board's Order

[28] Pursuant to s335(3)(a) of the Act, the Board confirms the Registrar's decision appealed against.

Costs and Publication

Costs

[29] Under section 338(4) of the Act the Board may order any party to the appeal to pay to any other party to the appeal any or all of the costs incurred by the other party in respect of the appeal.

[30] The Board has adopted the approach taken by the District Court to costs on appeal.

[31] Based on the above, the Board's costs order is that neither party is to pay costs to the other party.

Publication

[32] Section 339 of the Act provides:

339 Orders as to publication of names


- (1) *On an appeal under this subpart, the appeal authority may, if in its opinion it is proper to do so, prohibit the publication of the name or particulars of the affairs of a licensed building practitioner or any other person.*
- (2) *In deciding whether to make an order under subsection (1), the appeal authority must have regard to—*
 - (a) *the interests of any person (including, without limitation, the privacy of any complainant); and*
 - (b) *the public interest.*
- (3) *If the appeal authority prohibits the publication of the name or particulars of the affairs of a licensed building practitioner, the Registrar must remove the name or particulars of the affairs of that licensed building practitioner from the register in relation to the matter under appeal to the extent necessary to reflect the appeal authority's prohibition on publication.*

[33] Based on the above, the Board **will not** order further publication.

Right of Appeal

[34] The right to appeal a Board decision of this type is provided for in section 330(2) of the Actⁱ.

ⁱ **Section 330 Right of appeal**

- (2) *A person may appeal to a District Court against any decision of the Board—*
 - (a) *made by it on an appeal brought under subsection (1)*

Section 331 Time in which appeal must be brought

An appeal must be lodged—

- (a) within 20 working days after notice of the decision or action is communicated to the appellant; or*
- (b) within any further time that the appeal authority allows on application made before or after the period expires.*
