TERMS AND CONDITIONS FOR THE USE OF THE LBP LOGO

The Crown (“we”, “us”, “our”), acting by and through the Chief Executive of the Ministry of Business, Innovation and Employment, owns the LBP logo (the logo). This agreement sets out the terms under which we authorise you to use the logo.

BY USING THE LOGO, YOU AGREE THAT YOU WILL:

1. Only use the logo while you are an LBP and only to promote yourself as an LBP.
 2. Cease using the LBP logo if you are suspended (either voluntarily or otherwise) or if your LBP licence is cancelled or if we direct you to.
 3. Only use the logo in its entirety, except that you may change its size or use it in black and white.
 4. Ensure, when using the logo to advertise yourself as an LBP that any medium that features the logo (excluding stationary or signage) includes the following statement in writing or orally: **Always check the LBP Register to ensure your building practitioner is Licensed**
 5. Ensure, when using the logo to advertise a company you are associated with, that the company is stated on your record on the public LBP register and that any medium that features the logo includes the following statement in writing or orally: **We regularly engage LBPs. Always check the LBP Register to ensure your building practitioner is licensed.**
 6. Not use the logo in any way that could mislead the public or bring the LBP scheme into disrepute.
 7. Immediately inform the company listed on the LBP Register as associated with you if you cease to be an LBP or if we direct you to stop using the logo.
 8. Not use, register or apply to register any other sign or logo that is, in our view, potentially misleading while you are an LBP or at any other time.
 9. Not copy or forward an electronic copy of the logo to any person or organisation except for in the course of its ordinary use (i.e. your printer or sign writer).
 10. Not dispute ownership of the logo at any time or register or apply to register the logo.
 11. Indemnify us against all loss, damage, liability, cost and expense suffered or incurred by us as a result of your breach of these terms, including where you misrepresent yourself as being an LBP.
- > You understand that if you breach the terms of this agreement, action may be taken against you, including under the Building Act 2004, the Fair Trading Act 1986 or the Copyright Act 1994.
- > We reserve the right to change the terms of use of the logo or replace it with another logo at any time, and you agree to comply with any such changes.
